The meeting of the Ashland Town Council was called to order at 7:05 p.m. on Tuesday, May 11, 2004 in the Council Chambers of Town Hall by Angela Lawrence LaCombe, Mayor.

Resolution for Nina Peace/Post Office naming

Mayor LaCombe read into the record a resolution for Nina Killian Peace.

RESOLUTION

Whereas, Nina Killian Peace was an important part of the Ashland Community for thirty years, and
Whereas, Nina was elected to represent the Ashland District on the Hanover Board of Supervisor in 1974 at the age of twenty-five as the first woman elected to the Board and continued to serve in that capacity until 1990, as a chairperson in 1980 and vice chairperson in 1979, 1985 and 1986, and
Whereas, Nina served an instructor at Randolph Macon College in Ashland from 1979 until 1985, and
Whereas, Nina served as Juvenile and Domestic Relations District Court judge, 15th Circuit Virginia from 1990 until 1996, and

Whereas, She was a founding member of Hanover’s Domestic Violence Task Force and court appointed special advocates program, and

Whereas Nina served in leadership positions in numerous community and civic organizations including Ashland Rescue Squad, Hanover Rotary, Hanover Child Protection Team, Ashland Christian Emergency Services, Hanover Heart Association, Ashland Women’s Resource Center, Hanover Arts & Activities Center, Ashland Christmas Parade, Hanover Christmas Mother Project, Leadership Metro Richmond, Ashland Youth Soccer, Cub Scouts, Ashland Junior Women’s Club, Ashland Women’s Club, Henry Clay Women’s Club and

Whereas Nina K. Pease scholarship has been established at Patrick Henry High School, and
Whereas throughout her life Nina has received numerous awards including the 1991 Award by the Ashland Chamber of Commerce and the 1988 Annual Human Rights Award by Hanover County Community Services Board and

Whereas Nina was dedicated to her family and her church and the Ashland Hanover community until her death.

Now, Therefore, the Ashland Town Council does hereby note with great sadness the loss of a true Ashlander and endorses a proposal to rename the Ashland, Virginia Post Office in the honor and memory of Nina K. Peace.
